# President's Report Ray Whitley

Year two of CNIE-RCIE and counting:

After the success of conference 2008 in Banff, your board of directors further consolidated the AMTEC/CADE merger and began to plan your Association's future. As you might expect with volunteers spread from coast to coast, every action took rather longer than we anticipated, but CNIE-RCIE remains on a firm footing, despite the pressures on membership and participation resulting from the recession last fall. It is my pleasure to work with so collegial a group as your board, and I anticipate our Association's further development during 2009-10 under Maureen Baron's guidance.

Special kudos to Raymond Guy, Past President, as he leaves the board for a well-deserved spell of relative ease. We all hope he will remain active in the Association and its administration in the years ahead.

Especially during the first half of my tenure, much of our efforts were focused on the implementation of the new website design. Translation of the Association's constitution and bylaws, data transfer, and a tangle of overlapping, earlier contracts and responsibilities delayed its launch until summer 2008. Happily, it is now stable and managed under contract by an Alberta-based service supplier. My thanks to Maria Chow who, as Website Committee chair, was very busy making the site viable, and to executive administrator, Tim Howard, for much of the data transfer.

It's gratifying to see our new brand out there and at your service. On the website, members will now find links to complete electronic archives for both our academic periodicals, The Journal of Distance Education and the Canadian Journal of Learning & Technology. In addition, both Journals are not only published three times annually, they are also now fully electronic, so that their reach and utility to our members and the academic community is dramatically increased. Thanks to Mark Bullen and Michele Jacobsen for their success in making the scholarly publications of the Association more freely accessible.

As a counterpoint to these post-secondary periodicals, and an additional service to CNIE-RCIE's K-12 membership community, your board is considering an e-zine for K-12 issues as an adjunct to our online presence. While current economic realities may delay its inception, Vice-president Maria Chow is developing a detailed project proposal for the active consideration of the Board later in 2009.

Another highlight for me was the brokering, through the good offices and diligence of Bill Fricker, Terry Anderson at Athabasca University, and staff at NAIT, of an agreement by means of which both the CIDER and Wise & Witty Wednesday PD sessions became free services for members. Even if they cannot attend each & every presentation, these sessions provide significant, frequent professional development opportunities on-line throughout the year- another example of your Association walking the walk, as well as just talking about open and distance education.


As usual, many committees worked behind the scenes to make things happen: communications, awards, journals, professional development, website, international

relations and conference organization. Without their diligence, the Association could not address its objectives. I wish to thank the committee chairs and their teams for their continuing diligence and judgement.

I regret that the board's call to the membership for additional committee volunteers did not produce the level of response we had anticipated, but we continue to work towards the further development of committee activity. We recently posted to the list serve a membership survey which will help the board to plan for your needs. On the national and international front, your board prepared during last year to represent our Association at CRTC hearings on net throttling which are still pending. Finally, your board worked extensively with our colleagues at the Canadian Healthcare Association to prepare the 2009 conference. Your participation at Ottawa demonstrates the value of our Canadian Network in fostering innovation, sound management, and best practices in mediated learning here and around the world. Your board looks forward to continuing the dialogue online; at the 2010 conference in Saint John; and in 2011, in Hamilton. Be seeing you...



#### **AUDITORS' REPORT**

To the Members, Canadian Association for Distance Education.

We have audited the balance sheet of Canadian Association for Distance Education as at March 31, 2008 and the statements of revenue and expenditure and cash flows for the year then ended. These financial statements are the responsibility of the association's management. Our responsibility is to express an opinion on these financial statements based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

Note 4 to the financial statements reports the total revenue and total expenditure of the conference. The books and records supporting these activities are located with the host organization and were not available for audit purposes. We were not able to satisfy ourselves concerning the validity of these amounts by alternative means. Accordingly, we were not able to determine whether any adjustments might be necessary to assets, members' equity, conference revenue and net revenue for the year.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to examine the books and records of the conference as referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the association as at March 31, 2008 and the results of its operations and cash flows for the year then ended in accordance with Canadian generally accepted accounting principles. As required by the Canada Corporations Act, we report that, in our opinion, these principles have been applied on a basis consistent with that of the preceding year.



#### NOTES TO FINANCIAL STATEMENTS

#### MARCH 31, 2008

#### 1. INCORPORATION

The Canadian Association for Distance Education was established in 1983 and was incorporated under Part II of the Canada Corporations Act on 12 May 1993. The objective of the Association is to foster excellence in the provision of distance education in Canada. The Association is registered as a tax-exempt charity with Canada Revenue Agency and with the Ministry of Revenue of Quebec.

#### 2. SIGNIFICANT ACCOUNTING POLICIES

#### (a) Basis of Accounting

Revenue and expenditures are recorded on the accrual basis, whereby they are reflected in the accounts in the period in which they have been earned and incurred respectively, whether or not such transactions have been finally settled by the receipt or payment of money.

#### (b) Volunteer Services

The Association receives the services of volunteers, the cost of which cannot be reasonably estimated. Therefore, no representation of this expenditure has been included in these financial statements.

# (c) Use of Estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues and expenditures and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### 3. FINANCIAL INSTRUMENTS

The Association's financial instruments consist of cash, short-term deposits, accounts receivable and accounts payable and accrued liabilities. Unless otherwise noted, it is the Board of Director's opinion that the Association is not exposed to significant interest rate, exchange rate, or credit risks arising from these financial instruments. The fair values of these financial instruments approximate their carrying values, unless otherwise stated.

#### NOTES TO FINANCIAL STATEMENTS

#### MARCH 31, 2008

#### 4. CONFERENCE REVENUE

The Conference is typically hosted by various member organizations across the nation on behalf of the Association. The revenues and expenditures of the Conference are considered revenues and expenditures of the Association with gross revenues and expenditures shown below. The surplus (deficit) from the Conference is accounted for by the Association as the net amount on the statement of revenue and expenditure transferred by (to) the lead host organization.

CADE's conference revenue includes \$10,361 or 50% of their portion as reported above. The remaining 50% is due to the Association for Media and Technology in Education in Canada (AMTEC).

#### 5. SECRETARIAT FEES

Administrative and secretarial services are provided by the Canadian Society for the Study of Education (CSSE). An annual fee is paid each year for the services. Only six months fee was charged for the year ending March 31, 2008, due to the transfer of operations to Canadian Network for Innovation in Education, as described in note 6.

#### 6. FUTURE OPERATIONS

During the year, members of the Association voted in favour of combining the operations of the Association with the operations of the Association for Media and Technology in Education in Canada (AMTEC), whose members also voted in favour of the combination. The Association will commence a voluntary revocation of its charitable status and cease operations. The Canadian Network for Innovation in Education (CNIE) was incorporated on November 26, 2007 and has assumed CADE's membership operations for the period September 2007 to August 2008, as well as operations for the journal and other association activities occurring subsequent to its incorporation.

Each of the four competitive award categories (AMTEC Trust, Graduate Student Stipend Award, Awards of Excellence and Media Festival) received submissions, and winners were chosen as a result of a well defined review process. There was a good distribution of projects from across Canada touching on a variety of the latest trends in innovative educational practice. The majority of the 22 English and French Awards of Excellence and the 14 English and French Media Festival projects were submitted electronically into drop-boxes on the CNIE website. The jurors likewise used electronic scoring rubrics. This is a major step forward for this committee, and we want to thank Tim Howard and Brad Johnson for the smooth transition.

The Awards Banquet sub-committee has worked diligently at merging, blending and streamlining the process for both the Awards of Excellence and the Media Festival. Marketing, promotion activities, juror recruitment and scoring reviews are now

components of a single comprehensive process with the same timelines. We have worked to create one seamless process that is working well.

As its foundation, this sub-committee used the recommended, bilingual awards as identified by the merger committee and approved by the board of directors. In doing so, committee members have aimed to preserve the values of the past; while presenting a new and inclusive process for the future. Last year, new plaques for award winners, a fresh and informative brochure, and a lively multi-media presentation at the banquet were well received. These strategies will be revised and repeated again this year.

The Graduate Student Stipend sub-committee has worked conscientiously over the past two years to increase awareness of this stipend among graduate students across Canada. As an outcome, eleven high-quality submissions were made this year, attesting to the fact that research into distance, online, blended and/or distributed learning is vibrant. We anticipate that this interest will sustain.

# Website Report 2008-2009 Maria Chow

# **Drupal Content Management System**

This year marked a change in the management of the website. A decision was made by the Board of Directors to move existing content into a Content Management System. Drupal, a free, open-source Content Management System became the tool of choice. Such an approach reduces redundancy, decreases costs in terms of licensing fees, and is user-friendly. Its' extra features such as the ability to create blogs will allow for future growth and expansion.

Drupal was installed on the existing server without any major technical problems. The transition was smooth although some minor bugs were experienced during the application of the existing CNIE template. These were quickly solved and had no major impact upon the user.

## Maintenance and Expansion

Until recently the CNIE website was maintained on a volunteer basis by two Board members, Maria Chow and Tim Howard. While Drupal is easy to use, difficulties arose due to time constraints. This volunteer model did not take into account the Board members daily work obligations. Websites changes or updates that needed to be made according to a deadline were sometimes missed. A contract with an outside source for website maintenance and updates is now in place. Tim and Maria still have administrative rights and do update the site whenever possible to reduce costs.

During the past year, a module for the online submission of entries to some CNIE awards was added to the CNIE Website. The module allows for submissions to be made and for the jury members to adjudicate online.

# Canadian Journal of Learning and Technology Michele Jacobsen

This report summarizes publication activity for the 34th Volume of the *Canadian Journal* of *Learning and Technology* (CJLT). In the past year, the editorial team was able to maintain a fairly regular publication and distribution schedule for the journal and published three solid issues. In brief, two open issues and one special issue of the journal were published for the international academic community in 2008, comprised of 4 editorials, 3 book reviews and 20 scholarly articles (Table 1). A special issue of CJLT on **Electronic Portfolios**, edited by Elizabeth Meyer, Concordia University, constituted the Fall 2008 issue, V34.3.

Winter 2008, Volume 34.1 - This was an open issue and contained an editorial by Michele Jacobsen, two book reviews and six articles, including one in French (four research papers, a position paper and a literature review). The sixteen authors who contributed their scholarship to this issue are educational technology researchers affiliated with higher education institutions across Canada (i.e., New Brunswick, Alberta, Ontario & Quebec). This volume contains the article nominated for the CJLT Editor's Award, 2008, by Ellen Rose & Kate Tingley, entitled "Science and math teachers as Instructional Designers: Linking ID to the ethic of caring".

**Spring 2008, Volume 34.2** - This was an open issue that consisted of an editorial by Michele Jacobsen, one book review and eight articles, one in French, which explored diverse areas of educational technology research (six research papers, two position papers). The fourteen authors who have contributed their research and critical perspectives to this issue hail from universities across Canada and the United States.

Fall 2008, Volume 34.3 - Volume 34.3 is a special issue on Electronic Portfolios and consists of an editorial by Elizabeth Meyer, Concordia University, an editorial by Michele Jacobsen and six articles (one in French). The authors present research and perspectives that represent the international scope of this topic with submissions from France, the United States of America, Canada, the Netherlands and China. The articles also demonstrate the high degree of flexibility and multiplicity of options currently available to professionals, scholars and educators interested in creating, researching, or teaching with EPs.

**Shift From Dual Medium To Open Access Academic Publishing** - It is worth noting that the Fall 2008 issue, V34.3, marks the passage of CJLT from a dual medium publication to an open access academic journal. At the April 2008 CNIE Board Meeting at the Annual Meeting in Banff, Alberta, the decision was taken to publish both of CNIE's peer reviewed journals, the Journal of Distance Education (JDE) and the Canadian

Journal of Learning and Technology, as open access, open source journals starting in 2009. Therefore, the Fall 2008 print issue is the last hard copy version of CJLT that was distributed by mail to Canadian Network for Innovation in Education (CNIE) members. Starting with Volume 35 in Winter 2009, CJLT completes the transformation from dual media to a fully open access journal.

**Acceptance and Rejection Rates -** Journal activity was tracked to calculate the approximate acceptance / rejection rate for 2008. A total of 67 manuscripts were submitted in 2008 (which includes 48 English, 11 special issue and 8 French), a 19.5% increase over 2007 (n=54). CJLT published 20 articles in 2008 for an approximate acceptance rate of 29.8%, which is lower than the acceptance rate in 2007 (40%).

# Publication of Back Issues of CJEC on the CJLT Online Journal System

The 2008 calendar year saw the republication of 14 back issues of CJEC, Volume 15 – Volume 27, in the online journal system. A doctoral student at the University of Calgary was employed to design a method and approach to repurposing PDF content of several back issues of CJEC (provided by Ross Mutton, former AMTEC web master) for the OJS framework. This archival work was completed in February 2009, and incurred a one-time cost for CNIE. The editor published an appeal in the Spring 2008 issue: If members of the former AMTEC and CADE communities, and present CNIE community, can help to locate CJEC back issues from between 1979 – 1985, and earlier versions of Media Message, these can be scanned and electronically archived on the CJLT website.

Canadian Association of Learned Journals - http://www.calj-acrs.ca/
In 2008, the editor, Michele Jacobsen, renewed CJLT's membership in the Canadian
Association of Learned Journals (CALJ). CALJ was organized in 1990 to ensure the wellbeing of learned journals in Canada as important disseminators of scholarly work.
Representing over 100 Canadian journals, CALJ concentrates its efforts on three main
areas: education, promotion and lobbying.

#### Looking Forward

In closing, the current editorial team continues to be successful in publishing CJLT on a regular basis and have ensured that it remains a high quality, international scholarly journal. Attention the journal remains high, as indicated by a healthy submission rate.

Between January and March 2009, CJLT received 12 new submissions and received 3 more new submissions the first two weeks of April 2009.

#### **New Editor for CJLT**

As editor, I have greatly enjoyed the academic challenge of editing CJLT since 2005, and being a part of the growth of a new association, CNIE. The editor has worked with the CNIE Board and a small group from CJLT's Editorial Board to draft a "Request for Proposals" for a new English editor for CJLT in 2009. I will work with the incoming editor for an issue or two in order to ease the transition and to ensure that there is no disruption to the editorial review, peer review and publication cycle.
