President's Report Maureen Baron

Conferences: The 2009-2010 CNIE-RCIÉ year began with the successful conference, Media Festival and Awards ceremony held at the Château Laurier in Ottawa in May 2009. CNIE-RCIÉ and CHA (the Canadian Healthcare Association) contributed to a diverse conference program and opened invigorating cross-disciplinary conversations and idea sharing opportunities. Thierry Karsenti's keynote presentation epitomized this cross-disciplinary occasion through the melding of the fields of educational technology, distance education and medical practitioner education.


Canadian Copyright Law: CNIE-RCIÉ President, Maureen Baron, attended and spoke at the Montreal leg of the federal government's Round Table on Canadian Copyright Law. CNIE-RCIÉ, through the listserv, consulted the membership on their thoughts, ideas and recommendations regarding a future Canadian Copyright law. The resulting feedback was incorporated into CNIE-RCIÉ's submission to the federal government's consultation on proposed Canadian Copyright laws. This submission is available on CNIE-RCIÉ's website.

Membership Committee: Under the Chairmanship of Bill Fricker, a membership committee was created to make recommendations on how to increase the membership in CNIE-RCIÉ. The Board of Directors accepted the committee's report and has already instituted some of the recommendations. The report will be available, to the membership, on the CNIE-RCIÉ website. Other recommendations will be instituted in the coming year.

CNIE-RCIÉ and AECT letter of agreement: Professional development is about networking, connections and working in partnerships. Therefore CNIE-RCIÉ and AECT have initiated a formal relationship for their members. A relationship that will benefit the members, support and enhance collegiality and communication between both organizations. Any fully paid up members of CNIE-RCIÉ, i.e. membership is paid for one year and is a resident of Canada, may become a member of AECT's international electronic membership group for 50% of the cost of the AECT membership for the same period. Such members will only have access to AECT's electronic resources. Any AECT member whose membership has been paid for one year and is a resident of the United States of America, may become an electronic member of CNIE-RCIÉ for 50% of the cost of the CNIE-RCIÉ membership for the same period.

CNIE-RCIÉ and CAUCE: CNIE-RCIÉ's President and Secretary-Treasurer met with CAUCE's Board of Directors to discuss ways in which the two organizations could collaborate, especially in the area of professional development. To that end, a joint committee was established to explore different options for shared professional development.

Wise and Witty Wednesdays: WWW will be retired at the end of June 2010 and Bill Fricker will move on to other endeavors. A joint committee, including members of the Board of Directors from both CNIE-RCIÉ and CAUCE, has been created to look at new formats and mandates for Wise and Witty Wednesdays.



AUDITORS' REPORT

To the Members, Canadian Network for Innovation in Education.

We have audited the balance sheet of Canadian Network for Innovation in Education as at September 30, 2009 and the statement of revenue and expenditure for the year then ended. These financial statements are the responsibility of the Network's management. Our responsibility is to express an opinion on these financial statements based on our audit.

Except as explained in the following paragraph, we conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we plan and perform an audit to obtain reasonable assurance whether the financial statements are free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statement presentation.

Note 5 to the financial statements reports the total revenue and total expenditure of the conference. The books and records supporting these activities are located with the host organization and were not available for audit purposes. We were not able to satisfy ourselves concerning the validity of these amounts by alternative means. Accordingly, we were not able to determine whether any adjustments might be necessary to assets, net assets, conference revenue and net revenue (expenditure) for the year.

In our opinion, except for the effect of adjustments, if any, which we might have determined to be necessary had we been able to examine the books and records of the conference as referred to in the preceding paragraph, these financial statements present fairly, in all material respects, the financial position of the Network as at September 30, 2009 and the results of its operations and cash flows for the year then ended in accordance with Canadian generally accepted accounting principles.



NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 30, 2009

1. INCORPORATION

On June 27, 2007, the Canadian Association for Distance Education (CADE) and the Association for Media and Technology in Education in Canada (AMTEC) signed a Memorandum of Understanding that their organizations cease operations and a new organization be formed. The Canadian Network for Innovation in Education (CNIE) was established in 2007 and was incorporated under Part II of the Canada Corporations Act on November 26, 2007. The organization attempts to connect educators, administrators and practitioners in a bilingual, Canadian network. Our Network promotes research and advances practice in both open and distance education and the use of educational technologies. CNIE addresses all educational contexts, including K-12, post-secondary, and private sector. For Canadian income tax purposes, the Network is qualified as a not-for-profit organization, which is exempt from income tax under the Income Tax Act.

2. SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting

Revenue and expenditure are recorded on the accrual basis, whereby they are reflected in the accounts in the period in which they have been earned and incurred respectively, whether or not such transactions have been finally settled by the receipt or payment of money.

(b) Volunteer Services

The Network receives the services of volunteers, the cost of which cannot be reasonably estimated. Therefore, no representation of this expenditure has been included in these financial statements.

(c) Use of Estimates

The preparation of financial statements in conformity with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, revenues and expenditures and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. FINANCIAL INSTRUMENTS

The Network's financial instruments consist of cash, accounts receivable and accounts payable and accrued liabilities. Unless otherwise noted, it is the Board of Director's opinion that the Network is not exposed to significant interest rate, exchange rate, or credit risks arising from these financial instruments. The carrying amounts reported on the balance sheet for these financial instruments approximate fair values due to their immediate or short-term maturities.

NOTES TO FINANCIAL STATEMENTS

SEPTEMBER 30, 2009

4. CAPITAL MANAGEMENT

The Network considers its Capital to be the balance maintained in its Net Assets. The primary objective of the Network is to invest its Capital in a manner that will allow it to continue as a going concern and comply with its stated objectives. Capital is invested under the direction of the Board of Directors of the Network with the objective of providing a reasonable rate of return, minimizing risk and ensuring adequate liquid investments are on hand for current cash flow requirements. The Network is not subject to any externally imposed requirements of its Capital.

5. CONFERENCE REVENUE

The Conference is typically hosted by various member organizations across the nation on behalf of the Network. The revenues and expenditures of the Conference are considered revenues and expenditures of the Network with gross revenues and expenditures shown below. The surplus from the Conference is accounted for by the Network as the net amount on the statement of revenue and expenditure transferred by the lead host organization.

All these entries above have a classification (School System K-12, Post Secondary, or Government/Commercial/Industrial) and use Video, Graphics, Animation, Audio or Websites within a number of sub-categories (Instructional, Informational or Creative).

We like to thanks the UBC Office of Learning Technology and Telestudios for donating their studio space, technical support, internet access and viewing equipment for the media festival judging committee.

Each of the three competitive award categories (AMTEC Trust, Graduate Student Stipend Award, and the Awards of Excellence) received submissions, and winners were chosen as a result of a well defined review process. There was a good distribution of projects from across Canada touching on a variety of the latest trends in innovative educational practice. The majority of the 40 English and French Awards of Excellence projects were submitted electronically into drop-boxes on the CNIE website. The jurors likewise used

electronic scoring rubric. This electronic process continues to need refinement and will be improved for the future.

The Awards Banquet sub-committee has reviewed and revised the former merging, blending and streamlining of the process for both the Awards of Excellence and the Media Festival. The new Awards Festival is the holistic result. Marketing, promotion activities, juror recruitment and scoring reviews are now components of a single comprehensive process with the same timelines. We have worked to create one seamless and inclusive process.

The Graduate Student Stipend sub-committee received a response of 8 high-quality submissions this year, attesting to the fact that it has been successful in sustaining an awareness of this particular award on a national level. While the interest remains high, the funding for this award is set to run out in the coming year, so a decision will have to be made at the organizational level on whether or not this award should be continued and how its sustain its funding.

The AMTEC Trust Board has seen a few changes during the past year. Mark Ackerman completed his three-year term as President and Dr. F. Barry Brown has replaced Mark as President. Robert Powell resigned at about the same time as Mark and was replaced by AMTEC Past President, Gail Saunders. Most recently, Trustee Doug Pinder also resigned to devote himself to additional responsibilities at the Alberta Distance Learning Centre. The Trust will be seeking a replacement Trustee in the months ahead. We thank Mark, Robert & Doug for their dedication and energy directed toward the Trust and wish them the best in their future activities.

Going forward, Ray Whitley will continue his role as Secretary-Treasurer for the AMTEC Trust, Cindy Ives continues as the senior Trustee at large, all under the strong leadership of Dr. Barry Brown.

Funding for the Trust has not reached expected levels during the past year, but we have been able to fund one graduate student bursary in 2010. The downturn in the economy and very low interest rates has limited Trust growth. The continued generosity of CNIE members is very welcome, but we still need diligently to pursue present and new areas of Trust support.

We on the CNIE Board and Award sub-committees offer our sincere congratulations to all of this year's winners and our best wishes for their continued success.

The Awards committee wishes to thank all the volunteers and the CNIE directors who participated in the adjudication process. We hope they will continue to volunteer. As the adjudication process is confidential, names have been included with the full list of CNIE association volunteers attached to the CNIE annual report. As the CNIE organization grows, I encourage the membership to get involved in the variety of interesting committee opportunities.

CNIE Membership Promotion Strategies

During the summer of 2009, a Committee of CNIE- RCIÉ directors – Lorraine Carter and Helena Fehr – chaired by former CADE president, Bill Fricker, discussed ways to enhance CNIE's- RCIÉ's membership. Additional input was provided by: Maureen Baron and Maria Chow (CNIE-RCIÉ directors), Tim Howard (Director of Administration), and Brad Johnson (web design, BB Webmedia.)

The Committee reviewed the results of an online survey (administered by CNIE- RCIÉ members Bettina Brockerhoff-McDonald and Maureen Baron) which collected information about CNIE members' work and professional interests. Lorraine Carter shared the results of the Canadian Association of University Continuing Education (CAUCE) Institutional Members Survey, which summarized member feedback on numerous member services and priorities. Both documents are appended to the Committee's report.

Report Structure

Seven overarching categories ranging from implementing specific marketing tactics to addressing membership privileges (CNIE- RCIÉ services and supports) were identified:

Canadian Journal of Learning and Technology Michele Jacobsen

This report summarizes publication activity for the 35th Volume of the *Canadian Journal* of Learning and Technology (CJLT). In the past year, the editorial team published the Winter 2009 issue. At present, the Spring 2009 issue is close to publication (target: April 30) and the Fall 2009 issue is in preparation. In brief, all three issues in 2009 are open issues – no special topical issue was targeted for 2009.

Winter 2009, Volume 35.1 - This was the first exclusively online version of the *Canadian Journal of Learning and Technology*, which completes the transformation from dual media to a fully open-access, peer-reviewed academic journal. This is an open issue and contains an editorial by Michele Jacobsen and ten articles. The first five papers (four research papers and a position paper) were submitted in response to an open call for manuscripts, and were prepared by eighteen researchers from across Canada and one from Botswana, Africa. The final five papers in this issue of CJLT, prepared by eight researchers from Canada, Australia and China, share a focus on knowledge building, and were shepherded through the peer review and editing process by guest editors, Drs. Bill Egnatoff and Marlene Scardamalia.

Spring 2009, Volume 35.2 - This open issue consists of an editorial by Michele Jacobsen, a Commentary, two book reviews and five articles, which explore diverse areas of educational technology research (four research papers, one position paper). Ten authors have contributed their research and critical perspectives to this issue who hail from universities across Canada and the United States. This volume contains the article nominated for the CJLT Editor's Award, 2009, by Jay Wilson and Richard Schwier, University of Saskatchewan, entitled "Authenticity in the Process of Learning about Instructional Design".

Fall 2009, Volume 35.3 – This open issue is currently in preparation with 2 articles 'in hand' and several more in the peer review process. This will be the final issue edited by Michele Jacobsen for CJLT.

Shift From Dual Medium To Open Access Academic Publishing - A project that happened "behind the scenes" with CJLT in 2009 was the archiving of fourteen volumes of *Canadian Journal of Educational Communications* [CJEC] on the CJLT website. Forty (yes, 40!) back issues of CJEC from V. 15 in 1986 – V. 27 in 2001, have been archived and are now available online. This archival work was completed in February 2009, and incurred a one-time cost for CNIE. Thank you to Ross Mutton, Carleton University (retired), for rescuing the precious files from the defunct AMTEC website, and to Barb

Brown, educational technology doctoral student, University of Calgary, for working with the editor on this successful project.

Acceptance and Rejection Rates – Once the Fall 2009 issue is published, the submission and acceptance rates will be calculated for the year.

New Editorial Team for CJLT – Between 2005 – 2009, the current editorial team will have published 15 issues of CJLT. As Editor, I have greatly enjoyed the academic challenge of stewarding this peer-reviewed journal and being a part of the growth of a new association, CNIE. Still, it is time for me to move on to new academic and scholarly challenges. In past months, it has been wonderful to work with Rick Schwier, Katy Campbell, François Desjardins, Rick Kenny, Mark Bullen, Bruce Clark and the CNIE Board to find a new editor for CJLT.

Thank you to the CNIE President, Maureen Baron, for allowing me to bring the following two recommendations forward for Editor in Chief and Associate Editor of CJLT during the February 2010 CNIE Board Meeting. I am delighted that the CNIE Board unanimously approved these two recommendations:

Dr. Heather Kanuka, University of Alberta, to be appointed the new English Editor in Chief, CJLT

Dr. Martha Burkle, SAIT, to be appointed as the new Associate Editor, to work with the Editor in Chief.

Drs. Kanuka and Burkle will start their 3-year term with the publication of the Winter 2010 issue of CJLT. Heather, Martha and I have already begun the transition from one editorial team to another; the three of us will work to ensure that there is no disruption to the editorial review, peer review and publication cycle. Dr. Jennifer Lock, University of Calgary, continues as Book Review Editor. I look forward to the energy, research strengths and innovative ideas that Heather and Martha bring to CJLT, and wish them well.

I want to thank Dr. François Desjardins, UOIT, for yeoman service as the Associate Editor (French) - it has been a sincere pleasure working with François, who has served the journal well for more than 8 years. There are two new Associate Editors (French) who will work with Heather Kanuka and François Desjardins to transition to the task of editing and managing the peer review of French articles in Educational Technology: Anne Boerger & Donald Ipperciel, Faculty St. Jean, University of Alberta. Welcome!!
